Discipline, Committee on

The Committee on Discipline (COD) considers cases of alleged misconduct by students and student organizations that are brought to its attention. The Committee acts with power in all circumstances, including suspension and expulsion of a student from the Institute, revocation of a degree, revocation of recognition for a student group, and loss of a student organization residence. A COD decision to suspend or expel a student, revoke a degree, revoke recognition of a student group, or terminate a student organization residence may be appealed to the Chancellor on grounds described by the COD Rules.

The Committee on Discipline consists of six elected members of the Faculty, three undergraduate and three graduate students, and, *ex officio* voting, the Vice Chancellor for Student Life and the Vice Chancellor for Graduate and Undergraduate Education, or their representatives. Past members who have completed their terms may, for a period of three years thereafter, be called to fill out a quorum for a particular hearing, only one such member to serve in a given hearing.
